Please continue to follow safety measures and precautions such as physical distancing, capacity or gathering limits, wearing of masks, use of sanitizers and/or frequent handwashing, refrain from sharing items, and to sanitize and disinfect areas. Please refer to websites for details.

2. It is anticipated that as of June 15, 2021, inter-island air travel restrictions will be lifted by the State of Hawaii. Please use your discretion for inter-island traveling. However, Hawaii Kyodan State Committees, please continue to meet online for the remainder of the year (2021). If a committee needs to have an in-person meeting, please contact Headquarters for consultation and arrangements.
3. Local temple leaders, please use your discretion taking into consideration your ability to ensure safety measures including sanitation and disinfection and the overall sentiment of your membership and temple staff and/or volunteers as to whether you open or not for in-person services, events and activities. If your temple is not ready to reopen, please consider continuing to provide online spiritual services, meetings and events. Another possibility is a hybrid presentation of in-person attendance and online attendance of services, meetings and events.
4. It is anticipated that when the percentage of vaccinations reaches or surpasses 60% and/or 70%, new directives, recommendations and guidelines will be issued by government agencies and thus, please continue to follow the news and/or visit official government websites for the most recent updates.
