# Eligible Expenses



- Rent or Home Owners Association (HOA) Fees between the months of August 1, 2020 to December 28, 2020 (we will NOT take applications after this date).
  - **NOTE: If the applicant owes for any month between April – July 2020 (or even before), this RRHAP assistance can ONLY be applied to payments for either: August 2020, September 2020, October 2020, November 2020, December 2020.**
- Maximum rent assistance for Oahu is \$2,000.00/month/household
- Maximum rent assistance for Neighbor Islands is \$1,500.00/month/household
- Maximum HOA assistance is \$500.00/month/household
- Payment will go straight to the Vendor
- We cannot pay for a month that has already been paid for by applicant or another entity
- We cannot duplicate assistance so please inform applicants that they should ONLY APPLY through you, or if they did it on their own – to do it on their own again and not through a partner
- Mortgage assistance can be provided if it prevents foreclosure and a loan modification has been approved by Lender
- Financial/Budgeting Counseling, Housing Counseling, Foreclosure Mitigation, Loan Modification referrals

# Eligibility

- Full-time residents occupying their primary residence in the State of Hawaii
- 18 years of age or older
- Demonstrated loss of income directly resulting from the COVID19 pandemic
- No asset limit
- Current household gross income of 100% AMI or below

# Documents

- Please collect ALL documents BEFORE completing and submitting the application:
  - Valid Government issued ID for head of household/main applicant
  - Social Security Card for ALL adults
    - 19 holders – Valid Gov ID will be in lieu of SS card. Substitute last 4 of ID number in the application for last 4 of SSN.
  - Documentation of loss of income due to COVID19 (employment lay off/furlough letter, closure ,etc.)
  - For all adults: Unemployment/PUA verification of application with status of claim OR weekly benefit amount statement
  - For all adults working: 2 most current paystubs from application date
  - Any other types of income the household is receiving: social security, disability, welfare, etc.
    - Food Stamps is NOT included



# Documents Continued...



- If applying for Rent, please submit Rental Agreement
- If applying for HOA, please submit HOA statement
- If applying for Mortgage, please submit mortgage statement + foreclosure notice + loan modification approval letter

# Other Things to Be Aware of



- We cannot pay for households with Section 8 or residing in Hawaii Public Housing
- We cannot pay a family member of the applicant
- We cannot pay late fees
- Eviction moratorium for non-payment of rent is scheduled to be lifted end of 08/31/2020
- Plus Up (stimulus) Unemployment Benefit (\$600.00) ended
- If an applicant is going through AUW or an AUW partnered agency, depending on where they are at in applying, they should stay with AUW. We leave that determination to you.
